

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Referring Water Management Committee Resolution to  
Appropriate Legislative Committees)

LEGISLATIVE ORDER NO. 36-90

1 WHEREAS, on Friday, February 9, 1990 the Tohono O'Odham Legislative  
2 Council reviewed Appropriation items; and

3 WHEREAS, the Water Resources Department, Acting Director presented  
4 Water Management Committee Res. No. 01-90 requesting Water  
5 Trust Funds for round trip airfares and per diem for three  
6 Water Management Committee members to accompany the  
7 Nation's Appropriations Delegation to Washington, D.C.;

9 WHEREAS, a draft resolution was presented for Council consideration  
10 which authorized usage of the Water Trust Fund for this  
11 request; and

12 WHEREAS, a request was made to forward the request to the  
13 appropriate Legislative Committees.

14 NOW, THEREFORE, BE IT ORDERED that it hereby refers Water  
15 Management Committee Res. No. 01-90 to all appropriate  
16 Legislative Committees for review and recommendation prior  
17 to Council reconsideration.

18 The foregoing Legislative Order was passed by the Tohono O'odham  
19 Council on the 9th day of February, 1990 at a meeting at which a  
20 quorum was present with a vote of 1,660.5 for; 63.5 against;  
21 -0- not voting; 01 absent, pursuant to the powers vested in the  
22 Council by Section 1 (a) of Article VI of the Constitution of the  
23 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
24 January 18, 1986, and approved by the Acting Deputy Assistant  
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
26 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
