

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing San Lucy District to Continue Current Operations until  
a Budget is in Place, upon approval, Budget shall be  
Retroactive to October 01, 1990)

RES. NO. 369-90

1 WHEREAS, the San Lucy District has prepared a budget for fiscal  
2 year 1991, which was approved for review by the  
3 Legislative Council during its September 26, 1990 General  
4 Session, and;

5 WHEREAS, legislative actions on issues preceding the San Lucy  
6 District Budget consumed a considerable amount of time  
7 restraining the Legislative Council from conducting a  
8 thorough review of the budget, and;

9 WHEREAS, the Legislative Council is unable to review the budget  
10 until their October General Sessions, which will surpass  
11 the existing authorization for the District to expend  
12 funds; and


13 WHEREAS, it is in the best interest of the San Lucy District that  
14 the existing authorization be continued until such time  
15 that the Legislative Council conducts a thorough review  
16 of the budget and approves of same.

17 NOW, THEREFORE BE IT RESOLVED BY THE LEGISLATIVE COUNCIL that it  
18 does hereby authorize the San Lucy District to continue  
19 their current operations until a budget is approved.

20 BE IT FURTHER RESOLVED that upon approval, said budget shall be  
21 retroactive to October 01, 1990.

23 The foregoing Resolution was passed by the Tohono O'odham Council  
24 on the 27th. day of September, 1990 at a meeting at which a quorum  
25 was present with a vote of 1,660.5 for; 63.5 against; -0- not  
26 voting; 04 absent, pursuant to the powers vested in the Council  
27 by Section 1 (d)(2)(3) of Article VI of the Constitution of the  
28 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
29 January 18, 1986, and approved by the Acting Deputy Assistant  
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
31 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
