17 as herein above indicated.

18 BE IT FURTHER RESOLVED that the Chairman and other appropriate
19 officers of the Tohono O'Odham Nation reduce this final
20 determination in writing regarding each of the foregoing
21 applications for enrollment in accordance with Section 3
22 (c) of Article III of the Enrollment Ordinance; give
23 notice of this Council's determination in accordance with
24 Section 4 of Article III of the Enrollment Ordinance; and
25 place the names of each applicant upon the membership roll
26 of the Tohono O'Odham Nation in accordance with Article
27 V of the Enrollment Ordinance.

28 The foregoing Resolution was passed by the Tohono O'Odham Council
29 on the 15th. day of October, 1990 at a meeting at which a quorum
30 was present with a vote of 1,246.5 for; 63.5 against; 414.0 not
31 voting; and -0- absent, pursuant to the powers vested in the
32 Council by Section 1 of Article II and of Section 1 (h) of Article
VI of the Constitution of the Tohono O'Odham Nation, adopted by the
Tohono O'Odham Nation on January 18, 1986 and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).




