
1 WHEREAS, the following named person(s) have formally relinquished

8 membership roll.


9 The foregoing resolution was passed by the Tohono O'odham Council
10 on the 15th. day of October, 1990, at a meeting at which a quorum
11 was present with a vote of 1,077.5 for; 530.0 against; 116.5
12 not voting; and -0- absent; pursuant to the powers vested in the
13 Council by Section 3 of Article II and Article VI Section 1 (h) of
the Constitution of the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary -Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).


