

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment to Resolution No. 293-90)

RES. NO. 375-90

1 WHEREAS, it has come to the attention of the Enrollment Committee
2 that Robert A. Miranda, 1190-ST-86, had his membership
3 mistakenly relinquished by Council Resolution No. 293-90
4 on September 10, 1990; and

5 WHEREAS, the Committee recognizes that this was a clerical mistake
6 and that Robert A. Miranda and/or his guardian(s) never
7 intended and never requested to relinquish his membership
8 in the Tohono O'odham Nation.


9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
10 Council that it amends its Resolution No. 293-90, passed
11 on September 10, 1990 to delete the name of Robert A.
12 Miranda, 1190-ST-86, from the list of members requesting
13 relinquishment.

14 BE IT FURTHER RESOLVED that his name be restored to the membership
15 rolls of the Tohono O'odham Nation as originally
16 recognized by Resolution No. 141-88, passed on the 8th of
17 June 1988.

18 BE IT FURTHER RESOLVED that all rights of membership be restored
19 to Robert A. Miranda, 1190-ST-86 from the date of his
20 original enrollment on June 8, 1988.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 15th day of October, 1990 at a meeting at which a quorum was
24 present with a vote of 1,386.0 for; 221.5 against; 116.5 not
25 voting; 03 absent, pursuant to the powers vested in the Council
26 by Section 3 of Article II and Section 1 (h) of Article VI of
27 the Constitution of the Tohono O'odham Nation, adopted by the
28 Tohono O'odham Nation on January 18, 1986, and approved by the
29 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on
30 March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
31 (48 Stat. 984).
