

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adoption of the San Lucy District Budget for FY 1991)

RES. NO. 376-90

1 WHEREAS, the San Lucy District Council has considered and reviewed  
2 its proposed activities for FY '91 and prepared a budget  
3 to cover anticipated costs and expenses; and

4 WHEREAS, the San Lucy District Council did approve a proposed  
5 budget for FY '91 in the amount of \$1,148,400.65, said  
6 budget is to commence on October 01, 1990 and end on  
7 September 30, 1991; and

8 WHEREAS, the San Lucy District budget in the amount of  
9 \$1,148,400.65 has prepared segregating projected  
10 expenditures per line item, which are properly attributed  
11 to the District's purely governmental operations costs in  
12 the amount of \$92,341.73 and P. L. 99-503 funds in the  
13 amount of \$1,056,058.92, that are available through the  
14 Nation for the P. L. 99-503 budget; and

15 WHEREAS, the Budget & Finance Committee of the Tohono O'Odham  
16 Legislative Council did review the FY 1991 budget of the  
17 San Lucy District on September 25, 1990 and recommends  
18 approval.

19 NOW, THEREFORE BE IT RESOLVED by the Tohono O'Odham Legislative  
20 Council that the FY 1991 budget for the San Lucy District  
21 is hereby approved commencing October 01, 1990 to  
22 September 30, 1991 in the amount of \$1,148,400.65 .

23 BE IT FURTHER RESOLVED that draw down requests will be issued on  
24 a regular basis and will be transferred via wire transfer  
25 from P. L. 99-503 funds directly to Valley National Bank  
26 in Gila Bend, Account No. 2186-1432 each bi-weekly.

27 BE IT FURTHER RESOLVED that the use of "Earnest Money", line item  
28 No. 9120, in the Land Use and Economic Development  
29 Planning Board budget is subject to the approval of the  
30 San Lucy District Council and the Tohono O'Odham  
31 Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 15th. day of October, 1990 at a meeting at which a quorum was present with a vote of 769.0 for; 534.0 against; 421.0 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
