6 budget for October 01, 1990 and ends on September 30,  
7 1991; and

8 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the  
9 proposed budget and approves of same.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
11 Council that it hereby approves the Chukut Kuk District  
12 Council budget to be expended in accordance with the  
13 attached budget.

14 BE IT FURTHER RESOLVED that the budget shall be retroactive  
15 effective October 1, 1990.


16 The foregoing Resolution was passed by the Tohono O'odham Council

18 was present with a vote of 1,103.0 for; 418.5 against; 202.5 not  
19 voting; 01 absent, pursuant to the powers vested in the Council  
20 by Section 1 d(3) of Article VI of the Constitution of the Tohono  
21 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
22 1986, and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
24 16 of the Act of June 18, 1934 (48 Stat. 984).


