4	WHEREAS, a concern was that Legislative Committees tend to reserve
5	the right to conduct their their meetings in closed
6	sessions, excluding fellow Council Members; and
7	WHEREAS, questions were raised on the procedures utilized by a
8	Committee to determine the necessity of closing their
9	meeting; and
10	WHEREAS, it was noted by some of the Committees that the meetings
11	are closed when items sensitive in nature are discussed
12	and/or at the request of the person(s) addressing the
13	Committee; and
14	WHEREAS, a point of discussion in this matter concluded that all
15	Committee meetings should be open to any Member of the
16	Council.
17	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative
18	Council that all Council Members are hereby permitted to
19	attend any Committee whether or not they are a duly
20	certified Member of that Committee.
21	BE IT FURTHER ORDERED that a Council Member will not be denied
22	admittance to any Committee Meeting conducted in Closed
23	Session.
24	BE IT FURTHER ORDERED that the Legislative Secretary is hereby
25	authorized to draft this Legislative Order.
26	The foregoing ORDER was DEFEATED by the Tohono O'odham Council on the <u>17th</u> day of <u>October, 1990</u> at a meeting at which a quorum was
27	present with a vote of <u>611.0</u> for; <u>1,113.0</u> against; <u>-0-</u> not voting; <u>0 1</u> absent, pursuant to the powers vested in the Council by Section
28	$\frac{1(a)}{1(a)}$ of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
29	and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
30	the Act of June 18, 1934 (48 Stat. 984).
