

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Evaluation Report by Coopers & Lybrand)

RES. NO. 383-90

1 WHEREAS, the Tohono O'odham Nation hired the Accounting and
2 Consulting firm of Coopers & Lybrand to perform a
3 management study of the Accounting Department and its
4 operations; and

5 WHEREAS, the Coopers & Lybrand firm completed the study and
6 presented their findings and recommendations to the
7 Legislative Council; and

8 WHEREAS, the Legislative Council has the responsibility of the
9 fiscal assets of the Tohono O'odham Nation; and

10 WHEREAS, the Legislative Council has reviewed the accounting
11 evaluation report and concurs with the recommendations;
12 and

13 WHEREAS, the Legislative Council has determined that immediate
14 implementation of the recommendations outlined in the
15 report will enhance the sound financial management of the
16 Nation; and

17 WHEREAS, the implementation process will require consistent
18 monitoring and coordination, which can be best provided
19 for by the firm of Coopers & Lybrand.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
21 Council does hereby adopt the evaluation report on the
22 Nation's Accounting Department as presented.

23 BE IT FURTHER RESOLVED that the firm of Coopers & Lybrand be
24 retained to monitor the implementation of the
25 recommendations provided for in the evaluation report.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 18th. day of October, 1990 at a meeting at which a quorum
29 was present with a vote of 1,641.0 for; -0- against; 83.0 not
30 voting; 0 absent, pursuant to the powers vested in the Council by
31 Section 1 (d)(2), (f) of Article VI of the Constitution of the
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
