

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Request from Higher Education Services to Use Tribal Funds)

RES. NO. 385-90

1 WHEREAS, the Tohono O'odham Nation does operate the Higher
2 Education Services under P. L. 93-638 contract with the
3 Bureau of Indian Affairs; and

4 WHEREAS, the Tohono O'odham Legislative Council, by Resolution No.
5 223-90 did accept and request the Bureau of Indian Affairs
6 to recontract with the Tohono O'odham Nation for services
7 during fiscal year 1991; and

8 WHEREAS, due to the delay of funding appropriations for FY 1991 by
9 the U.S. Government, the Higher Education Services has
10 submitted a budget for \$41,795.00 to cover costs for fall
11 1990 semester subsistence to eligible students for the
12 months of October through December, 1990; and

13 WHEREAS, such tribal request will ensure the continuation of
14 assistance to eligible students until dollars are
15 received.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
17 Council does authorize the utilization of tribal funds for
18 FY 1991.

19 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council
20 does request that the Chairman, Vice Chairman and any
21 designated official ensure that the Tribal appropriations
22 to Higher Education Services for scholarships, in the
23 amount of \$41,795.00, be reimbursed from the B.I.A.
24 contract after a contract is negotiated and in place.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 18th. day of October, 1990 at a meeting at which a quorum
27 was present with a vote of 1,724.0 for; -0- against; -0- not
28 voting; 02 absent, pursuant to the powers vested in the Council
29 by Section 1 (d)(2) of Article VI of the Constitution of the
30 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
31 January 18, 1986, and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
