

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Memorandum of Agreement between Arizona Department of
Economic Security and the Tohono O'odham Nation)

RES. NO. 387-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the Job
2 Opportunities Basic Skills (JOBS) Program funded by the
3 Department of Health and Human Services, Family Support
4 Administration (DHHS/FSA); and

5 WHEREAS, the JTPA/JOBS Personnel has established a working
6 relationship with the Arizona Department of Economic
7 Security (ADES) in the determination of the Tohono O'odham
8 Nation's total AFDC adult population residing on the
9 reservation, and in the determination of the designated
10 service area; and

11 WHEREAS, the Department of Health and Human Services, Family
12 Support Administration (DHHS/FSA) requires that a formal
13 agreement be developed and established between the Arizona
14 Department of Economic Security (ADES) and the Nation in
15 regards to the working relationship between the two
16 entities; and


17 WHEREAS, the JTPA/JOBS Program has submitted for review and final
18 approval the attached Memorandum of Agreement between the
19 Arizona Department of Economic Security and the Tohono
20 O'odham Nation.

21 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
22 Council does hereby approve the Memorandum of Agreement
23 between the Arizona Department of Economic Security and
24 the Tohono O'odham Nation.


25 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
26 that the Tohono O'odham Nation's Officials, to wit: the
27 Chairman, Vice Chairman and any designated official are
28 hereby authorized to negotiate and execute the agreement,
29 provided however, that any amendments affecting the
30 funding or funding levels of this agreement shall be
31 submitted for further prior approval by this Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 18th. day of October, 1990 at a meeting at which a quorum
3 was present with a vote of 1,411.5 for; 63.5 against; 249.0 not
4 voting; 02 absent, pursuant to the powers vested in the Council
5 by Section 1 (f) of Article VI of the Constitution of the Tohono
6 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
7 1986, and approved by the Acting Deputy Assistant Secretary -
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
9 16 of the Act of June 18, 1934 (48 Stat. 984).



24 submittal.


