3 Congress of American Indians; and

4 WHEREAS, on October 16, 1990, by Legislative Council Resolution No.  
5 377-90, all Council Members were given the opportunity to  
6 attend the National Congress of American Indians  
7 Convention in Albuquerque, New Mexico; and

8 WHEREAS, the Tohono O'odham Legislative Council believes that it  
9 is in the best interest of the Tohono O'odham Nation that  
10 the membership and participation in the National Congress  
11 of American Indians be continued.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
