

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recharge Feasibility Study Extension)

RES. NO. 395-90

1 WHEREAS, the Water Resources Committee is the oversight committee
2 on all water related issues on the Tohono O'odham Nation;
3 and

4 WHEREAS, Resolution No. 206-90 authorizes the Recharge Feasibility
5 Study to be extended to the end of October, 1990 and that
6 the final recommendations of the Water Resources Committee
7 be provided to the Legislative Council; and

8 WHEREAS, the Water Resources Committee finds that additional
9 studies need to be completed before a recommendation is
10 made; and

11 WHEREAS, the Water Resources Committee is requesting an additional
12 extension of five (5) months to complete the assessment
13 as defined in Resolution No. 206-90; and

14 WHEREAS, the committee is requesting a budget of \$61,888 to
15 complete the Recharge feasibility assessment.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
17 Council hereby approves the recommendations of the Water
18 Resources Committee.

19 BE IT FURTHER RESOLVED that the budget of \$61,888 to complete the
20 Recharge feasibility assessment be utilized from the
21 Nation's Water Trust Fund.

22 BE IT FINALLY RESOLVED that the final recommendations of the Water
23 Resources Committee on recharge and other alternatives be
24 completed by March 1991.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 30th day of October, 1990 at a meeting at which a quorum
27 was present with a vote of 1,110.0 for; 557.0 against; 57.0 not
28 voting; 0 absent, pursuant to the powers vested in the Council by
29 Section 1 (a), (c), (d)(2) & (i)(2) of Article VI and Section 2 (a)
30 & (d) of Article XVII of the Constitution of the Tohono O'odham
31 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
32 and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
