28 BE IT FURTHER RESOLVED that the Chairman and other appropriate  
29 officers of the Tohono O'Odham Nation reduce this final  
30 determination in writing regarding each of the foregoing  
31 applications for enrollment in accordance with Section 3  
32 (c) of Article III of the Enrollment Ordinance; give  
notice of this Council's determination in accordance with  
Section 4 of Article III of the Enrollment Ordinance; and  
place the names of each applicant upon the membership roll


1 of the Tohono O'Odham Nation in accordance with Article  
2 V of the Enrollment Ordinance.

3 The foregoing Resolution was passed by the Tohono O'Odham Council  
4 on the 5th day of November, 1990 at a meeting at which a quorum  
5 was present with a vote of 1,249.5 for; 53.0 against; 421.5 not  
6 voting; and 04 absent, pursuant to the powers vested in the Council  
7 by Section 1 of Article II and of Section 1 (h) of Article VI of  
8 the Constitution of the Tohono O'Odham Nation, adopted by the  
9 Tohono O'Odham Nation on January 18, 1986 and approved by the  
10 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on  
11 March 6, 1986 pursuant to Section 16 of the Act of June 18, 1934  
12 (48 Stat. 984).






