

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY'91 Budget for Vi-ikam Doag Industries, Inc.)

RES. NO. 399-90

1 WHEREAS, Vi-ikam Doag Industries was chartered as a non-profit
2 public corporation to develop business and employment
3 opportunities in and for the San Lucy District; and

4 WHEREAS, the Board of Directors of Vi-ikam Doag Industries has
5 submitted an operating budget for FY '91 in the sum of
6 \$470,905.00 to support its activities on behalf of the
7 San Lucy District; and

8 WHEREAS, the San Lucy District Council has reviewed and approves
9 of the activities and expenditures proposed in the budget.

10 NOW, THEREFORE, IT BE RESOLVED by the Tohono O'odham Legislative
11 Council that the FY '91 budget for the Vi-ikam Doag
12 Industries, Inc. is hereby approved commencing November
13 11, 1990 to September 30, 1991 in the amount of
14 \$470,905.00.

15 BE IT FURTHER RESOLVED that quarterly financial reports of the Vi-
16 ikam Doag Industries be submitted to the Tohono O'odham
17 Nation's Accounting Department, the Commerce Committee,
18 the Budget and Finance Committee, and the Tohono O'odham
19 Legislative Council.

20 BE IT FURTHER RESOLVED that only the interest shall be used from
21 P.L. 99-503 Trust Fund to fund the \$470,905.00 budget.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 7th. day of November, 1990 at a meeting at which a quorum
24 was present with a vote of 1,607.5 for; 59.5 against; 57.0 not
25 voting; 04 absent, pursuant to the powers vested in the Council
26 by Section 1 (d)(3) of Article VI of the Constitution of the
27 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
28 January 18, 1986, and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
30 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
