

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(JTPA Title II-A Budget Amendment #1)

RES. NO. 400-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the JTPA  
2 Title II-A Program under the PY 1990 Contract with the  
3 State of Arizona; and

4 WHEREAS, any amendments affecting the funding or funding levels of  
5 the contract shall be submitted for review and approval  
6 by the Tohono O'odham Legislative Council; and

7 WHEREAS, the Tohono O'odham Nation has approved the new fringe  
8 benefit rate of 28% beginning October 01, 1990, an  
9 increase of 16%; and

10 WHEREAS, the original plan budget was \$327,847.00 with the variance  
11 of \$79,384.00 making a final total budget of \$407,231.00;  
12 and

13 WHEREAS, an amendment has been submitted for review and approval  
14 by the JTPA Title II-A Program.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
16 Council that it hereby approves Amendment #1 to the JTPA  
17 Title II-A Program.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
19 that the Tohono O'odham Nation's Officials, to wit: the  
20 Chairman, Vice Chairman and any designated official are  
21 hereby authorized to negotiate and execute the contract,  
22 provided however, that any amendments affecting the  
23 funding or funding levels of this contract shall be  
24 submitted for further prior approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council  
26 on the 7th. day of November, 1990 at a meeting at which a quorum  
27 was present with a vote of 1,724.0 for; -0- against; -0- not  
28 voting; 04 absent, pursuant to the powers vested in the Council  
29 by Section 1 (f) of Article VI of the Constitution of the Tohono  
30 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
31 1986, and approved by the Acting Deputy Assistant Secretary -  
32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
