

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(JTPA Title IV Budget Amendment #1)

RES. NO. 401-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the JTPA  
2 Title IV Program under the PY 1990 Grant with the United  
3 States Department of Labor; and

4 WHEREAS, any amendments affecting the funding or funding levels of  
5 the grant shall be submitted for review and approval by  
6 the Tohono O'odham Legislative Council; and

7 WHEREAS, the Tohono O'odham Nation has approved a new fringe  
8 benefit rate of 28% beginning October 01, 1990, an  
9 increase of 16%; and

10 WHEREAS, the original plan budget was \$539,279.00 and the estimated  
11 carry-in funds from PY 1989 in the amount of \$135,637.00  
12 was reduced to \$120,577.00 making a final total budget of  
13 \$524,219.00 for PY 1990; and

14 WHEREAS, an amendment has been submitted for review and approval  
15 by the JTPA Title IV Program.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
17 Council that it hereby approves Amendment #1 to the JTPA  
18 Title IV Program.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
20 that the Tohono O'odham Nation's Officials, to wit: the  
21 Chairman, Vice Chairman and any designated official are  
22 hereby authorized to negotiate and execute the grant,  
23 provided however, that any amendments affecting the  
24 funding or funding levels of this grant shall be submitted  
25 for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 7th. day of November, 1990 at a meeting at which a quorum  
28 was present with a vote of 1,724.0 for; -0- against; -0- not  
29 voting; 04 absent, pursuant to the powers vested in the Council  
30 by Section 1 (f) of Article VI of the Constitution of the Tohono  
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
