Council that it hereby approves the Head Start supplement
grant and authorizes expenditures on accordance with the
attached budget.
BE IT FURTHER RESOLVED, by the Tohono O'odham Legislative Council
that the Tohono O'odham Nation's Officials, to wit: the
Chairman, Vice Chairman and any designated official are
hereby authorized to negotiate and execute the grant,
provided however, that any amendments affecting the
funding or funding levels of the grant be submitted for
further prior approval by this Council.

January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
