

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Head Start Program Supplemental Grant)

RES. NO. 405-90

1 WHEREAS, the Tohono O'odham Nation has operated a Head Start
2 Program to provide and serve educational and pre-school
3 learning experiences for children between the ages of 3-
4 5 years; and

5 WHEREAS, the Department of Health and Human Services, Administra-
6 tion for Children, Youth and Families, has announced that
7 one-time supplemental funds for purchasing vehicles and
8 for travel to the National Indian Head Start Director's
9 Association Management Training Conference are available;


11 WHEREAS, the Head Start Program has prepared a proposal for
12 supplemental funds to be submitted to the Department of
13 Health and Human Services.

14 NOW, THEREFORE, IT BE RESOLVED by the Tohono O'odham Legislative
15 Council that it hereby approves the Head Start supplement
16 grant and authorizes expenditures on accordance with the
17 attached budget.

18 BE IT FURTHER RESOLVED, by the Tohono O'odham Legislative Council
19 that the Tohono O'odham Nation's Officials, to wit: the
20 Chairman, Vice Chairman and any designated official are
21 hereby authorized to negotiate and execute the grant,
22 provided however, that any amendments affecting the
23 funding or funding levels of the grant be submitted for
24 further prior approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 8th day of November, 1990 at a meeting at which a quorum
27 was present with a vote of 1,234.5 for; 243.5 against; 140.0 not
28 voting; 106.0 (03) absent, pursuant to the powers vested in the
29 Council by Section 1 (f) of Article VI of the Constitution of the
30 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
31 January 18, 1986, and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
