3	"Requesting Immediate Action for Continued Progress on the
4	Chui Chu Water Settlement Legislation; and
5	WHEREAS, this Resolution outlines the Sif Oidak District concerns
6	regarding the proposed Chui Chu water bill; and
7	WHEREAS, the District believes that the Nation is not pursuing its
8	priorities, with respect to water legislation, by
9	concentrating its efforts on the water issues raised in
10	the San Xavier District; and
11	WHEREAS, a request was made to proceed in closed session to allow
12	the Attorney General to address the District's concerns
13	without jeopardizing the clientele confidentiality rule.
14	NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative
15	Council does hereby proceed in closed session to address
16	the Chui Chu Water Settlement Legislation.
17	BE IT FURTHER ORDERED that the Sif Oidak District Vice Chairwoman
18	and the Attorney General remain in the Legislative
19	Chambers to address this item as presented.
20	The foregoing ORDER was passed by the Tohono O'odham Council on the 8th day of November, 1990 at a meeting at which a quorum was
21	present with a vote of 1,491.0 for; 127.0 against; -0- not voting; 106.0 (03) absent, pursuant to the powers vested in the Council
22	by Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
23	1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section
24	16 of the Act of June 18, 1934 (48 Stat. 984).
