

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Sanitation Facility Deficiencies)

RES. NO. 410-90

1 WHEREAS, Indian Health Service, Office of Environmental Health
2 (OEH), conducts an assessment of Sanitation Facilities
3 Deficiencies, annually; and

4 WHEREAS, the OEH assessment does have an impact upon Congressional
5 appropriations and IHS allocation of funds; and

6 WHEREAS, a Sanitation Deficiency Report was submitted for Council's
7 review; and

8 WHEREAS, the Tohono O'Odham Legislative Council determines that the
9 top ten Sanitation Deficiencies as listed on the report
10 are priorities.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation has
12 determined that the following deficiencies are the ten
13 most critical and desirable, in descending order of
14 prioritization:

- 15 1. Pisinemo
- 16 2. Hickiwan
- 17 3. San Miguel
- 18 4. Big Fields
- 19 5. Santa Rosa Village
- 20 6. Vamori
- 21 7. Anegam
- 22 8. Chui Chu
- 23 9. Ak Chin
- 24 10. San Lucy Farms

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 9th day of November, 1990 at a meeting at which a quorum
27 was present with a vote of 1,240.5 for; 343.5 against; 140.0 not
28 voting; 02 absent, pursuant to the powers vested in the Council
29 by Section 1(f) of Article VI of the Constitution of the Tohono
30 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
31 1986, and approved by the Acting Deputy Assistant Secretary -
32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).


