

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract with the Law Firm of
Strickland & Altaffer)

RES. NO. 418-90

1 WHEREAS, pursuant to Resolutions No. 329-89 and 345-90, the Tohono
2 O'odham Legislative Council approved a General Counsel
3 Contract, and Amendment No. 1 thereto, with the law firm
4 of Strickland & Altaffer under which such firm served as
5 General Counsel for the Tohono O'odham Nation pending
6 transfer to the Office of Attorney General of all legal
7 matters within that scope of representation; and
8 WHEREAS, the Office of Attorney General has assumed responsibility
9 for all general counsel matters formerly handled by
10 Strickland & Altaffer; and
11 WHEREAS, continuity in the provision of legal services to the
12 Nation makes it advisable to enter into a limited Attorney
13 Contract with Strickland & Altaffer to provide
14 transitional advice and consultation with respect to
15 certain mining issues and other matters transferred to the
16 Office of Attorney General; and
17 WHEREAS, the General Counsel Contract expires on December 18, 1990;
18 and
19 WHEREAS, on recommendation of the Attorney General, the Legislative
20 Council approved a budget for the Office of Attorney
21 General for fiscal year 1991, which included an allocation
22 of \$18,000 to fund an Attorney Contract with Strickland
23 & Altaffer during this fiscal year; and
24 WHEREAS, the Attorney General has proposed an Attorney Contract
25 with Strickland & Altaffer, a copy of which is attached
26 hereto, under which the firm would provide advice and
27 consultation with respect to certain mining issues and
28 transitional matters; and
29 WHEREAS, the Domestic Affairs Committee has recommended approval
30 of the Contract by the Council.
31 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
32 Council hereby approves the Attorney Contract with the law

firm of Strickland & Altafer, in the form attached hereto, and authorizes the execution of the Contract by the Chairman of the Tohono O'odham Nation, or his Designee, and approval thereof by the Attorney General.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th day of November, 1990 at a meeting at which a quorum was present with a vote of 1,109.0 for; 237.0 against; 378.0 not voting; 03 absent, pursuant to the powers vested in the Council by Section 2 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
