

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Incorporating "Revising Tribal Constitutions" Conference into  
December General Session)

LEGISLATIVE ORDER NO. 424-90

1 WHEREAS, on December 3, 1990, the Tohono O'odham Legislative  
2 Council considered attending the "Revising Tribal  
3 Constitutions" Conference in Tempe, Arizona on December  
4 7, 1990; and

5 WHEREAS, the conference occurs during the Council's General Session  
6 and there was a concern on whether or not all agenda items  
7 would be addressed prior to the conference; and

8 WHEREAS, a number of Council Members expressed interest in  
9 attending the conference and noted that the conference  
10 outline included information that would be beneficial to  
11 all Members of the Council; and

12 NOW, THEREFORE BE IT ORDERED that the Tohono O'odham Legislative  
13 Council hereby incorporates the "Revising Tribal  
14 Constitutions" conference into their December 7, 1990  
15 Session.


16 BE IT FURTHER ORDERED that the Tohono O'odham Legislative Council  
17 hold its December 7, 1990 Session at Tempe, Arizona for  
18 the purpose of attending the "Revising Tribal  
19 Constitutions" conference.

20 The foregoing ORDER was passed by the Tohono O'odham Council on the  
21 3rd day of December, 1990 at a meeting at which a quorum was  
22 present with a vote of 1,121.0 for; 321.5 against; 281.5 not  
23 voting; 01 absent, pursuant to the powers vested in the Council  
24 by Section 1(a) of Article VI of the Constitution of the Tohono  
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
