7, 1990; and

- WHEREAS, the conference occurs during the Council's General Session and there was a concern on whether or not all agenda items would be addressed prior to the conference; and
- WHEREAS, a number of Council Members expressed interest in attending the conference and noted that the conference outline included information that would be beneficial to all Members of the Council; and
- NOW, THEREFORE BE IT ORDERED that the Tohono O'odham Legislative

 Council hereby incorporates the "Revising Tribal

 Constitutions" conference into their December 7, 1990

 Session.
- BE IT FURTHER ORDERED that the Tohono O'odham Legislative Council hold its December 7, 1990 Session at Tempe, Arizona for the purpose of attending the "Revising Tribal Constitutions" conference.

The foregoing ORDER was passed by the Tohono O'odham Council on the 3rd day of December, 1990 at a meeting at which a quorum was present with a vote of 1,121.0 for; 321.5 against; 281.5 not voting; 01 absent, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
