

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(USDOL Notice of Intent
July 01, 1991 - June 30, 1993)

RES. NO. 437-90

1 WHEREAS, the Job Training Partnership Act was enacted into law in
2 1982, replacing the Comprehensive Employment and Training
3 Act (CETA); and

4 WHEREAS, funding is made available from the United States
5 Department of Labor, Division of Indian and Native
6 American Programs (USDOL/DINAP), to tribal governments to
7 establish programs for improving the employment prospects
8 of eligible persons; and

9 WHEREAS, pursuant to P. L. 97-300 Section 632.11 (c), Standard Form
10 424 and a statement indicating that the tribe meets the
11 requirements of Section 632.10 (c)(4) must be submitted
12 to the USDOL/DINAP by January 01 of the designation year;
13 and

14 WHEREAS, the JTPA Program has submitted for review the Standard
15 Form 424, Notice of Intent to Apply for Funds and the
16 statement from the Nation pursuant to Section 632.10
17 (c)(4) for Program Years 1991-1993.

18 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
19 Council does hereby approve the submission of the Standard
20 Form 424, Notice of Intent to Apply for funds, and the
21 statement that the tribe does meet the requirements of
22 Section 632.10 (c)(4).

23 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
24 that the Tohono O'Odham Nation's officials, to wit: the
25 Chairman, Vice-Chairman and any designated official are
26 hereby authorized to negotiate and execute the agreement,
27 provided however, that any amendments affecting the
28 funding or funding levels of this agreement shall be
29 submitted for further prior approval by this Council.

30 The foregoing Resolution was passed by the Tohono O'odham Council
31 on the 5th day of December, 1990 at a meeting at which a quorum
32 was present with a vote of 1,724.0 for; -0- against; -0- not
voting; -0- absent, pursuant to the powers vested in the Council
by Section 1(f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
