1	WHEREAS, on September 17, 1990, the Tohono O'odham Legislative
2	Council reviewed and referred the proposed Seat Belt Usage
3	Ordinance to the appropriate committees including the Law
4	Enforcement Department and the districts for their input
5	and recommendation; and
6	WHEREAS, the proposed ordinance was to be returned for Council
7	consideration within 90 days; and
8	WHEREAS, on December 5, 1990, the Tohono O'odham Legislative
9	Council again reviewed the Seat Belt Usage Ordinance; and
10	WHEREAS, a majority of the Council Members stated that the proposed
11	Seat Belt Usage Ordinance is still pending to be addressed
12	at their respective districts; and
13	WHEREAS, those districts that reviewed the proposed ordinance
14	questioned the section that stated that noncompliance with
15	the ordinance would be a criminal offense; and
16	WHEREAS, a recommendation was made to refer this item back to the
17	appropriate committees to look at amending the language
18	to make noncompliance of the ordinance a civil instead of
19	a criminal offense.
20	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative
21	Council that it hereby tables the proposed Seat Belt Usage
22	Ordinance.
23	BE IT FURTHER ORDERED that the proposed ordinance be referred to
24	the Domestic Affairs and the Judiciary Committees for
25	review and determination of the criminal/civil sections
26	of the ordinance.
27	BE IT FURTHER ORDERED that the proposed Seat Belt Usage Ordinance
28	be reconsidered at the March 1991 General Session of the
29	Council.
30	The foregoing ORDER was passed by the Tohono O'odham Council on the 5th day of December, 1990 at a meeting at which a quorum was
31	present with a vote of $1,554.0$ for; 53.5 against; 116.5 not voting; $-0-$ absent, pursuant to the powers vested in the Council by
32	Section <u>1 (a)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
