1 WHEREAS, the Legislative Council believes that the employees of
2 the Tohono O'odham Nation should receive a Christmas Bonus
3 in recognition of the services rendered to the Nation; and


4 WHEREAS, there are funds available in the general account of the
5 Nation for such purpose.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
7 Council does hereby appropriate the approximate sum of
8 \$110,000., to cover a Christmas Bonus payment to the
9 employees of the Nation.

10 BE IT FURTHER RESOLVED that each employee shall receive a Christmas
11 Bonus in the amount of \$200.


12 The foregoing Resolution was passed by the Tohono O'odham Council
13 on the 6th. day of December, 1990 at a meeting at which a quorum
14 was present with a vote of 1,182.5 for; 356.0 against; 185.5 not
15 voting; -0- absent, pursuant to the powers vested in the Council
16 by Section 1 (d)(2) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
