

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Task Force Committee on
BIA Reorganization)

RES. NO. 443-90

1 WHEREAS, the Bureau of Indian Affairs proposed for a reorganization
2 of the Bureau; and

3 WHEREAS, the Interior Appropriations Act, as amended, mandates a
4 Task Force consisting of Tribal, Bureau, and Department
5 representatives to provide consultation and to review any
6 Bureau reorganizational proposal; and

7 WHEREAS, various Tribes have delegated to Tribal organizations for
8 representation to the Task Force; and

9 WHEREAS, the Tohono O'Odham Nation intends to participate in the
10 Bureau of Indian Affairs Consultation process since it is
11 a major undertaking which could have serious future
12 impacts on the Nation; and

13 WHEREAS, the Tohono O'Odham Nation needs to assess the BIA
14 Reorganizational proposals and to make a determination of
15 its position.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
17 Council hereby appoints the Chairman's Designee of the
18 Executive Branch, Chief Judge of the Judicial Branch and
19 Legislative Council Chairman of the Legislative Branch to
20 the Task Force Committee on BIA Reorganization to assess
21 and make recommendations to the Legislative Council.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 6th. day of December, 1990 at a meeting at which a quorum
24 was present with a vote of for; 1,490.0 against; 107.0 not voting;
25 and 03 absent, pursuant to the powers vested in the Council by
26 Section 1(b) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).




