

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Judicial Services Budget Modification #1)

RES. NO. 44-90

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Judicial Services Program under FY-89 P. L. 93-638
3 contract with the Bureau of Indian Affairs; and

4 WHEREAS, any amendments affecting the funding or funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'Odham Legislative Council; and

7 WHEREAS, the Department of Interior has received in accordance
8 with the Appropriation Act of 1990 a reduction of 5.3%;
9 and

10 WHEREAS, the Bureau of Indian Affairs has requested the Nation to
11 submit revised budget modifications to reflect Gramm-
12 Rudman-Hollings reductions reflected in the Appropriation
13 Act of 1990; and

14 WHEREAS, an amendment has been submitted for review and approval.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
16 Council does hereby approve this amendment and authorizes
17 expenditures in accordance with the attached budget.

18 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
19 that the Tohono O'Odham Nation's officials, to wit: the
20 Chairman, Vice Chairman and any designated official are
21 hereby authorized to negotiate and execute the contract,
22 provided however, that any amendments affecting the
23 funding or funding levels of the contract shall be
24 submitted for further prior approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 21st. day of February, 1990 at a meeting at which a quorum
27 was present with a vote of 1,667.0 for; -0- against; 57.0 not
28 voting; 01 absent, pursuant to the powers vested in the Council
29 by Section 1(f) of Article VI of the Constitution of the Tohono
30 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
31 1986, and approved by the Acting Deputy Assistant Secretary -
32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
