

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(P.O.N.I Project Budget Modification)

RES. NO. 45-90

1 WHEREAS, the Tohono O'Odham Nation has been selected as a
2 participant under the Planning of New Institutions
3 (P.O.N.I Project) for construction of a Juvenile
4 Detention Center authorized by P. L. 99-570, Title
5 4-subtitle C-cited as the Indian Alcohol and Substance
6 Abuse Prevention and Treatment Act of 1986; and

7 WHEREAS, the Tohono O'Odham Nation did submit a budget to the
8 Bureau of Indian Affairs to begin the pre-development
9 phase of the contract to determine how the P.O.N.I
10 requirements will be implemented into the planning and
11 design of the juvenile detention and rehabilitation
12 center; and

13 WHEREAS, the contracting office of the Bureau of Indian Affairs,
14 Facilities Management and Construction does recommend the
15 reductions reflected in the attached budget modification,
16 to complete phase 1 of the project; and

17 WHEREAS, the Judicial Branch has submitted the budget modification
18 for review and approval by the Tohono O'Odham Legislative
19 Council.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
21 Council does hereby approve this amendment and authorizes
22 expenditures in accordance with the attached budget.

23 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
24 that the Tohono O'Odham Nation's officials, to wit: the
25 Chairman, Vice Chairman and any designated official are
26 hereby authorized to negotiate and execute the contract,
27 provided, however, that any amendments affecting the
28 funding or funding levels of this contract shall be
29 submitted for further prior approval by this Council.

30 The foregoing Resolution was passed by the Tohono O'Odham Council
31 on the 21st. day of February, 1990 at a meeting at which a quorum
32 was present with a vote of 1,724.0 for; -0- against; -0- not
voting; 01 absent, pursuant to the powers vested in the Council
by Section 1(f) of Article VI of the Constitution of the Tohono
O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
