WHEREAS, the Tohono O'odham Nation has submitted an application received grant award from the Department of Housing and Urban Development - Community Development Block Grant (CDBG), and in connection with such application and award resolved and made certain assurances.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that prior to the submission of its application, and amendments to the actual grant award, the governing body of the Tohono O'odham Nation has provided tribal citizens through their Council Representatives, especially those living in areas where activities are proposed or ongoing, with adequate information concerning the amount of funds available for proposed community development and housing activities, the range of activities that may be assisted, and other important program requirements and solicited their views and participation.

BE IT FURTHER RESOLVED that traditional Tribal means of citizen involvement were followed through District Council meetings and Tohono O'odham Legislative Council meetings, and opportunity was given to articulate needs, express preferences about proposed community development and housing activities, assist in the selection of district priorities, and otherwise participate in the development of the application.

BE IT FURTHER RESOLVED that no part of this paragraph shall be construed to restrict the responsibility and authority of the applicant for development of the application, or amendments thereto, and the execution of its Community Development Block Grant Program. Accordingly, the citizen participation requirements of this paragraph do
