

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization of SAWRSA Trust Funds for the San Xavier
C.A.P. Recharge and Riparian Rehabilitation Project Study
March - May 1990)

RES. NO. 54-90

1 WHEREAS, the San Xavier District Council (District) requested the
2 Tohono O'Odham Legislative Council (Council) to provide
3 authorization and associated costs, to conduct a study
4 for a recharge and riparian rehabilitation project
5 (Project) on the San Xavier Reservation using Central
6 Arizona Project (CAP) water; and

7 WHEREAS, the Council consented to the District's request without
8 authorization of funds pursuant to Tohono O'Odham
9 Legislative Council Res. No. 35-90; and

10 WHEREAS, the Council through the aforementioned resolution,
11 directed the District to devise a budget for the project
12 study for submission to the Council's Water Resources and
13 Budget and Finance Committees for review and
14 recommendations to the Council, thereupon, submitted to
15 the Council for final review and adoption; and

16 WHEREAS, the District has followed through on this directive in
17 developing the proposed project budget in concert with
18 the Council's Water Resources Committee; and

19 WHEREAS, the proposed project budget was presented to and
20 supported by the Council's Water Resources and Budget &
21 Finance Committees on February 20, 1990.

22 NOW, THEREFORE, BE IT RESOLVED that pursuant to Tohono O'Odham
23 Legislative Council Res. No. 35-90, the Council hereby
24 authorizes \$30,000.00 from the Southern Arizona Water
25 Rights Act of 1982 Trust Fund for the purpose of
26 analyzing the proposed San Xavier Recharge and Riparian
27 Rehabilitation Project as outlined in the attached budget
28 and justification and supporting documents.

29 BE IT FURTHER RESOLVED that the Council requests the Tohono O'Odham
30 Executive Branch's officials and administrators to
31 expedite this authorization in an efficient and timely
32 manner upon approval by Chairman Joaquin Sr.

The foregoing Resolution was passed by the Tohono O'odham Council on the 21st. day of February, 1990 at a meeting at which a quorum was present with a vote of 1,181.0 for; 301.5 against; 241.5 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1 (d) & Section 2 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
