12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
13	Council hereby approves the wage and salary level increase
14 15	in the amount of three percent (3%) for all employees,
16	elected and appointed officials of the Nation for fiscal
17	year 1991. This increase shall become effective on
18	October 01, 1990.
