

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY '91 Low Income Energy Assistance)

RES. NO. 57-90

1 WHEREAS, Low Income Energy Assistance funds have been made
2 available for a grant to the Tohono O'Odham Nation for
3 FY 1991 through the State of Arizona, Department of
4 Economic Security, Low Income Energy Assistance Program;
5 and

6 WHEREAS, the Tohono O'Odham Nation does meet the eligibility
7 requirements; and

8 WHEREAS, it is in the best interest of the Tohono O'Odham Nation
9 to apply for FY 1991 Low Income Energy Assistance to
10 assist needy families with utility bills; and


11 WHEREAS, the Tohono O'Odham Nation believes that it will satisfy
12 the eligibility criteria set forth in the funding and
13 reporting regulations.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
15 Council does hereby authorize the officials of the Tohono
16 O'Odham Nation to submit a request for Low Income Energy
17 Assistance funding from the State of Arizona, Department
18 of Economic Security.

19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's Officials, to wit: the
21 Chairman, Vice Chairman and any designated official are
22 hereby authorized to negotiate and execute the grants or
23 contracts, provided however, that any amendments
24 affecting the funding or funding levels of the grants or
25 contracts shall be submitted for further prior approval
26 by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 5th day of March, 1990 at a meeting at which a quorum was
29 present with a vote of 1,667.0 for; -0- against; 57.0 not
30 voting; 03 absent, pursuant to the powers vested in the Council
31 by Section 1(f) of Article VI of the Constitution of the Tohono
32 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
