

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1991 Parenting Skills Training)

RES. NO. 58-90

1 WHEREAS, the Tohono O'Odham Social Service Department has the
2 primary responsibility to provide prevention and
3 intervention services to families at risk for child abuse
4 and neglect; and

5 WHEREAS, the Arizona Department of Economic Security provides
6 funds for the development and administration of child
7 abuse and neglect prevention programs under specified
8 terms and conditions; and

9 WHEREAS, Parent Training has been identified as one means of
10 preventing child abuse and neglect; and

11 WHEREAS, the Tohono O'Odham Social Service Department has
12 successfully been providing Parenting Skills Education
13 under this contract for two years and is capable of
14 continued administration of the program.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
16 Council that it does hereby approve the application of
17 the Tohono O'Odham Social Service for a contract to focus
18 on decreasing the incidence of child abuse and neglect
19 through the provision of parent effectiveness training
20 and child development education reservation wide.

21 BE IT FURTHER RESOLVED that the term of this contract shall
22 commence as of July 01, 1990 and end on June 30, 1991.

23 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
24 that the Tohono O'Odham Nation's officials, to wit: the
25 Chairman, Vice Chairman and any designated official are
26 hereby authorized to negotiate and execute the contract,
27 provided however, that any amendments affecting the
28 funding or funding levels of the contract shall be
29 submitted for further prior approval by this Council.

30 The foregoing Resolution was passed by the Tohono O'odham Council
31 on the 5th day of March, 1990 at a meeting at which a quorum was
32 present with a vote of 1,610.0 for; -0- against; 114.0 not
voting; 03 absent, pursuant to the powers vested in the Council
by Section 1(f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
