LEGISLATIVE ORDER NO. 59-90

1 WHEREAS, on March 5, 1990, the Tohono O'odham Legislative Council  
2 proceeded with their March General Session; and

3 WHEREAS, the agenda item concerning the "Indian Child Welfare Act"  
4 case was sensitive in nature; and


5 WHEREAS, the Legislative Rules, under Article I, Section 1.F CLOSED  
6 SESSION provides that, "The Legislative Council may vote  
7 to proceed into Closed Session during which time only the  
8 Legislative Representatives, its Officers, persons  
9 providing testimony or advice, and others the Legislative  
10 Council may feel to be appropriate shall be present."

11 WHEREAS, a request was made to proceed into closed session.


12 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative  
13 Council that it hereby proceeds in Closed Session to  
14 address item number three, "Indian Child Welfare Act  
15 Case."

16 The foregoing Order was passed by the Tohono O'odham Council on  
17 the 5th day of March, 1990 at a meeting at which a quorum was  
18 present with a vote of 1,660.5 for; 63.5 against; -0- not voting;  
19 03 absent, pursuant to the powers vested in the Council by Section  
20 1 (a) of Article VI of the Constitution of the Tohono O'odham  
21 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
22 and approved by the Acting Deputy Assistant Secretary - Indian  
23 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
24 the Act of June 18, 1934 (48 Stat. 984).
