4 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
5 Council that it does hereby recognize that the above named
6 person(s) have relinquished their membership in this
7 Nation, and does hereby order that their name(s) be
8 deleted from the membership roll.

9 The foregoing resolution was passed by the Tohono O'odham Council
10 on the 5th day of March, 1990, at a meeting at which a quorum
11 was present with a vote of 1,137.5 for; 529.5 against;
12 57.0 not voting; and 03 absent; pursuant to the powers vested in
13 the Council by Section 3 of Article II and Article VI Section 1
14 (h) of the Constitution of the Tohono O'odham Nation on January
15 18, 1986, and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
17 16 of the Act of June 18, 1934 (48 Stat. 984).
