

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appropriation Priority List FY '91)

RES. NO. 63-90

1 WHEREAS, the Tohono O'Odham Legislative Council appointed a  
2 special delegation of Legislative Council Representatives  
3 to travel to Washington, D.C., to testify before the  
4 Appropriation Congressional Committees on the President's  
5 FY '91 Budget; and

6 WHEREAS, the Tohono O'Odham Legislative Council established  
7 priorities for Congress to consider in its appropriation  
8 hearings; and

9 WHEREAS, this listing of priorities are not inclusive and are  
10 intended to aid Congress in considering the Tohono  
11 O'Odham Nation's request for increased funding; and

12 WHEREAS, the Tohono O'Odham Legislative Council established the  
13 following ten (10) areas as the top priority based on the  
14 need and type of services provided to the people.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
16 Council that it does hereby adopt the following list of  
17 priorities and respectfully urges Congress to appropriate  
18 such funds as necessary to increase the ten (10) areas  
19 to an exemplary level of funding:

32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
