WHEREAS, the Tohono O'Odham Nation understands that diabetes mellitus is a major health problem and cause of suffering among the Tohono O'Odham people; and

WHEREAS, the Nation, through the Health Department and Human Services Department, offers programs concerned with management of diabetes in the communities; and

WHEREAS, present staffing in the Health Department and Sells Service Unit includes positions for diabetes care and counselling, but that these positions are inadequate to meet the high demand required by the high prevalence of diabetes in this community; and

WHEREAS, present staffing in the Health Department and Sells Service Unit does not include Registered Nurses specifically devoted to the care and education of patients with diabetes or adults at high risk to develop diabetes; and

WHEREAS, present staffing in the Health Department and Sells Service Unit does not include a Licensed/Registered Dietician or Nutritionist specifically devoted to the care and education of patients with diabetes or adults at high risk to develop diabetes; and

WHEREAS, present staffing at the Sells Service Unit provides for inadequate Podiatry Staff to fully cover diabetic clinics either in the clinics or community-based setting; and

WHEREAS, present staffing at the Tohono O'Odham Health Department is inadequate to develop a comprehensive and community based exercise/fitness program for diabetic patients and adults at high risk to develop diabetes; and

WHEREAS, the Tohono O'Odham Nation, through the Tohono O'Odham Health Department, wish to establish a network of high quality, community-based diabetes clinics on the Tohono O'Odham Nation.

1 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
2 Council that it does hereby urgently request that
3 Congress appropriate \$324,000.00 annually to the Tohono
4 O'Odham Nation for a Diabetes Treatment Program as
5 outlined in the attached proposal.

6 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
7 that the appropriate officers of the Nation are hereby
8 authorized and directed to bring this request to the
9 appropriate members and committees of Congress.

10 The foregoing Resolution was passed by the Tohono O'odham Council
11 on the 5th day of March, 1990 at a meeting at which a quorum was
12 present with a vote of 1,724.0 for; -0- against; -0- not voting;
13 02 absent, pursuant to the powers vested in the Council by Section
14 1 (f) of Article VI of the Constitution of the Tohono O'odham
15 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
16 and approved by the Acting Deputy Assistant Secretary - Indian
17 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
18 the Act of June 18, 1934 (48 Stat. 984).


