


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Support of Early Childhood Head Start Program
Appropriations Request)

RES. NO. 65-90

- 1 WHEREAS, the Early Childhood Head Start Program now provides
2 educational service to a total of 340 children in (11)
3 eleven districts throughout the Nation; and
- 4 WHEREAS, the increased operating cost of providing comprehensive
5 services to many children, parents and staff has been a
6 financial burden on the Early Childhood Head Start
7 Program; and
- 8 WHEREAS, Early Childhood Head Start has developed a 12 month
9 program to provide much needed services; and
- 10 WHEREAS, funding should be made available through the Tohono
11 O'Odham Nation; and
- 12 WHEREAS, Early Childhood Head Start has requested the Tohono
13 O'Odham Legislative Council to support the "Line Item
14 Appropriations" from Early Childhood Head Start efforts
15 in this matter.
- 16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
17 Council that it does hereby urgently request that
18 Congress increase its appropriations for \$250,824.00 for
19 the Tohono O'Odham Nation's Early Childhood Head Start
20 Program and that the appropriate officers of the Nation
21 are hereby authorized and directed to bring this request
22 to the appropriate members and committees of Congress.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 5th day of March, 1990 at a meeting at which a quorum was
25 present with a vote of 1,724.0 for; -0- against; -0- not voting;
26 02 absent, pursuant to the powers vested in the Council by Section
27 1 (f) of Article VI of the Constitution of the Tohono O'odham
Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
