

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Funding for Tohono O'Odham High School)

RES. NO. 66-90

1 WHEREAS, the Tohono O'Odham Nation continues to support funding
of the Tohono O'Odham High School; and

2 WHEREAS, there exists a need to have additional funding to
3 complete construction; and

4 WHEREAS, a feasibility study was conducted before construction of
5 school reflecting a need to have cottages built for
6 students who reside more than an hour's bus ride from
7 school; and

8 WHEREAS, Extra Curricular activities contributes to a healthy body
9 and a healthy mind, and that there is a need for
10 construction of larger locker room facilities and
11 playing field development including outdoor lights and
12 a sprinkler system; and

13 WHEREAS, Tohono O'Odham High School is presently out of compliance
14 with the Athletic Interscholastic Association due to
15 inadequate locker room facilities and playing fields; and

16 WHEREAS, adequate classroom facilities are needed to insure that
17 quality instruction and learning are on-going; and

18 WHEREAS, the present enrollment at Tohono O'Odham High School is
19 230 designating the need for more classroom space.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
21 Council respectfully request Congress to appropriate
22 funding for Tohono O'Odham High School for student
23 cottages, which was justified based on a feasibility
24 study indicating a need to have a residential program in
25 place, construction of adequate locker room facilities,
26 playing field development as required by the Athletic
27 Interscholastic Association to ensure membership, and
28 additional classroom space to ensure a comfortable and
29 healthy learning environment.

30 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
31 that it does hereby urgently request that Congress

increase its appropriations for Tohono O'Odham High School for the Tohono O'Odham Nation and that the appropriate officers of the Nation are hereby authorized and directed to bring this request to the appropriate members and committees of Congress.

The foregoing Resolution was passed by the Tohono O'odham Council on the 5th day of March, 1990 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
