

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Supporting Employment Assistance Program Appropriations Request)

RES. NO. 67-90

1 WHEREAS, the Employment Assistance Program now provides funding  
2 for students interested in obtaining Adult Vocational  
3 Education Training; and

4 WHEREAS, a major Tohono O'Odham Nation priority is to provide  
5 Adult Vocation Education Training to acquire highly  
6 skilled employees; and

7 WHEREAS, the number of applicants has steadily increased while at  
8 the same time the annual budget has decreased.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative  
10 Council does hereby urgently request that Congress  
11 increase its appropriations for the Employment Assistance  
12 Program in the amount of \$100,073.00 for the Tohono  
13 O'Odham Nation and that the appropriate officers of the  
14 Nation are hereby authorized and directed to bring this  
15 request to the appropriate members and committees of  
16 Congress.

17 The foregoing Resolution was passed by the Tohono O'odham Council  
18 on the 5th day of March, 1990 at a meeting at which a quorum was  
19 present with a vote of 1,724.0 for; -0- against; -0- not voting;  
20 03 absent, pursuant to the powers vested in the Council by Section  
21 1 (f) of Article VI of the Constitution of the Tohono O'odham  
22 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,  
23 and approved by the Acting Deputy Assistant Secretary - Indian  
24 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of  
25 the Act of June 18, 1934 (48 Stat. 984).
