1	WHEREAS,	federal appropriations for road maintenance for the
2		Tohono O'Odham Nation are currently set at \$258,000.00
3		and result in the attached operating budget for the
4		Branch of Roads of the Papago Agency which establishes
5	-	that there are approximately 325 miles of paved roads and
6		518 miles of earth roads within the Nation served by a
7		maintenance crew of six persons and twelve pieces of
8		equipment; and
9	WHEREAS,	because of funding constraints, the Branch of Roads is
10		currently able to maintain only 287 miles of 518 miles
11	4.	of earth roads, and is unable to effectively maintain the
12		increasing number of paved roads which are deteriorating
13		almost as rapidly as new paving is added to existing
14		earth roads; and
15	WHEREAS,	the Natural Resources Committee of the Legislative
16		Council has determined that a crisis will result if
17		existing roads are permitted to deteriorate at current
18		rates, and has recommended that the Nation see
19		additional appropriations for road maintenance; and
20	WHEREAS,	the Council concurs in the Committee's determination and
21		recommendation.
22	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
23		Council that it does hereby urgently request that
24		Congress increase its appropriations for \$1,863,490.00
25		for the Tohono O'Odham Nation's road maintenance and that
26		the appropriate officers of the Nation are hereby
27	/	authorized and directed to bring this request to the
28		appropriate members and committees of Congress.
