the United States Department of the Interior-Bureau of WHEREAS, Reclamation (Reclamation) has notified the Secretary of the Interior that there will be a potential write-in.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation hereby requests the support of Congress to appropriate Interior-Bureau of sufficient funding for the Reclamation's Small Reclamation Loan Program to suffice the forthcoming proposed Schuk Toak Small Reclamation Loan request.

The foregoing Resolution was passed by the Tohono O'odham Council on the 5th. day of March, 1990 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
