

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Nation's Support for the Schuk Toak
Small Reclamation Loan)

RES. NO. 70-90

1 WHEREAS, the Tohono O'Odham Legislative convened in a meeting on
2 March 05, 1990 to consider approval of this resolution
3 to allow the Legislative Council's Appropriation
4 Committee to lobby for the Small Reclamation Loan for the
5 Schuk Toak New Development; and

6 WHEREAS, the Development is a part of the Southern Arizona Water
7 Rights Settlement Act of 1982 and according to the Act,
8 the Federal Government is responsible for pipelines,
9 canals, ditches and irrigation appurtenances, and the
10 Tohono O'Odham Nation is responsible for land
11 subjugation; and

12 WHEREAS, in order to take advantage of the award, the Tohono
13 O'Odham Nation is applying for a Small Reclamation Loan
14 in the amount of \$8,089,200.00 to pay for land
15 subjugation and an Operations & Maintenance Facility and
16 the loan is expected to be approved in May 1990; and

17 WHEREAS, the United States Department of the Interior-Bureau of
18 Reclamation (Reclamation) has notified the Secretary of
19 the Interior that there will be a potential write-in.

20 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Nation
21 hereby requests the support of Congress to appropriate
22 sufficient funding for the Interior-Bureau of
23 Reclamation's Small Reclamation Loan Program to suffice
24 the forthcoming proposed Schuk Toak Small Reclamation
25 Loan request.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 5th day of March, 1990 at a meeting at which a quorum was
28 present with a vote of 1,724.0 for; -0- against; -0- not voting;
29 03 absent, pursuant to the powers vested in the Council by Section
30 1 (f) of Article VI of the Constitution of the Tohono O'odham
31 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
32 and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
