## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving General Counsel Subcontract)

WHEREAS,	the law firm of Strickland & Altaffer, P.C. ("Firm") is
	employed pursuant to a General Counsel Contract dated
	September 24, 1989, to represent the Tohono O'Odham
	Nation; and

whereas, the Firm did initiate an action for trespass, injunctive relief and damages on behalf of the Hickiwan District against the Arizona District Council of the Assemblies of God Church, Case No. 88-TRO-4396 of the Judicial Court of the Tohono O'Odham Nation (the "action"), and the Chief Prosecutor did obtain a default judgment and order of eviction against the defendants named in the action; and

WHEREAS, the defendants have filed a motion to set aside the default judgment and an application for an order in the nature of a temporary restraining order or clarification of judgment, and it may be necessary to further litigate the action; and

whereas, it is in the best interest of the Hickiwan District and the Nation that the District be represented in the action by independent counsel pursuant to the provisions of paragraph 6 of the Firm's General Counsel Contract.

NOW, THEREFORE, BE IT RESOLVED that in accordance with the provisions of paragraph 6 of the Firm's General Counsel Contract the Legislative Council does hereby approve the execution by the Firm of the attached Subcontract with the law firm of Linden, Chapa & Fields to represent the Hickiwan District in the action.

The foregoing Resolution was passed by the Tohono O'odham Council on the 6th. day of March, 1990 at a meeting at which a quorum was present with a vote of 780.5 for; 705.5 against; 238.0 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
