

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Base Roll Addition)

RES. NO. 91-90

1 WHEREAS, Section 1 (a) of Article II of the Constitution of the
2 Tohono O'Odham Nation provides that the Tohono O'Odham
3 Council can make additions and changes to the official
4 census rolls of the Sells and Gila Bend Reservations dated
5 January 1, 1937 and of the San Xavier Reservation dated
6 January 1, 1940, subject to the approval of the Secretary
7 of the Interior; and

8 WHEREAS, the Enrollment Committee has determined that the following
9 named person was a member of the Tohono O'Odham Nation on
10 the date of the respective census rolls but that their
11 name had been inadvertently omitted therefrom, and had
12 recommended that their name be added to the rolls; and

13 WHEREAS, the Tohono O'Odham Council has reviewed the recommenda-
14 tions of the Enrollment Committee and approves thereof.

15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that,
16 subject to the approval of the Secretary of the Interior,
17 the name of the following person be added to the official
18 census rolls of the Sells, Gila Bend or San Xavier
19 Reservation, to wit:

1513-SX-90 NORRIS, Lucy Ann (Lopez) (Dec'd) 4/4

20 BE IT FURTHER RESOLVED that the required approval be secured from
21 the Secretary of the Interior before their name be
22 formally added to such rolls.

23 The foregoing resolution was passed by the Tohono O'odham Council
24 on the 2nd day of April, 1990, at a meeting at which a quorum was
25 present with a vote of 1,724.0 for; -0- against; -0- not voting;
26 and 04 absent; pursuant to the powers vested in the Council by
27 Section 1 (a) of Article II and Section 1 (h) of Article VI of the
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986, and approved by the Acting
Deputy Assistant Secretary - Indian Affairs (Operations) on March
6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
