(Enrollment - April)

6 (b) of Article II of the Constitution of the Tohono O'Odham  
7 Nation, and that their applications are approved, as herein  
8 above indicated.

9 BE IT FURTHER RESOLVED that the Chairman and other appropriate  
10 officers of the Tohono O'Odham Nation reduce this final  
11 determination in writing regarding each of the foregoing  
12 applications for enrollment in accordance with Section 3  
13 (c) of Article III of the Enrollment Ordinance; give notice  
14 of this Council's determination in accordance with Section  
15 4 of Article III of the Enrollment Ordinance; and place the  
16 names of each applicant upon the membership roll of the  
17 Tohono O'Odham Nation in accordance with Article V of the  
18 Enrollment Ordinance.

19 The foregoing Resolution was passed by the Tohono O'Odham Council  
20 on the 2nd day of April, 1990 at a meeting at which a quorum was  
21 present with a vote of 1,664.5 for; -0- against; 59.5 not voting;  
22 and 03 absent, pursuant to the powers vested in the Council by  
23 Section 1 of Article II and of Section 1 (h) of Article VI of the  
24 Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
25 O'Odham Nation on January 18, 1986 and approved by the Acting  
26 Deputy Assistant Secretary - Indian Affairs (Operations) on March  
27 6, 1986 pursuant to Section 16 of the Act of June 18, 1934 (48  
28 Stat. 984).
