

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Weatherization Assistance Amendment)

RES. NO. 93-90

1 WHEREAS, the Tohono O'odham Nation is currently operating the  
2 Weatherization Assistance Program under a contract with  
3 the State of Arizona, Department of Commerce; and

4 WHEREAS, it is in the best interest of the Tohono O'odham Nation  
5 to extend the FY 1990 Weatherization Assistance Program  
6 for the period of April 01, 1990 through September 30,  
7 1990; and

8 WHEREAS, any amendment affecting the funding or funding level of  
9 the contract shall be submitted for review and approval  
10 by the Tohono O'odham Legislative Council; and

11 WHEREAS, an amendment has been submitted for review and approval.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
13 Council does hereby approve the amendment to the contract  
14 and authorizes expenditures in accordance with the  
15 attached budget.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
17 that the Tohono O'odham Nation's Officials, to wit: the  
18 Chairman, Vice Chairman and any designated official are  
19 hereby authorized to negotiate and execute the contract,  
20 provided however, that any amendments affecting the  
21 funding or funding levels of the contract shall be  
22 submitted for further prior approval by this Council.

23 BE IT FURTHER RESOLVED that the Tohono O'odham Nation approve the  
24 extension for the Weatherization contract effective April  
25 01, 1990 through September 30, 1990.

26 The foregoing Resolution was passed by the Tohono O'odham Council  
27 on the 2nd. day of April, 1990 at a meeting at which a quorum was  
28 present with a vote of 1,664.5 for; 59.5 against; -0- not  
29 voting; 03 absent, pursuant to the powers vested in the Council  
30 by Section 1 (f) of Article VI of the Constitution of the Tohono  
31 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
32 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
