4	possible in part by Title III of the Older American's Act
5	of 1965 as amended through the administration by the
6	Inter-Tribal Council of Arizona; and
7	WHEREAS, the Elderly Program has prepared a proposal for FY '91 for
8	Title III funding to provide nutritional and social
9	support services to eligible elderly members.
10	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
11	Council that it hereby approves the proposal for Title III
12	funding of the Elderly Program to continue to provide such
13	services it has proposed in light of the requirements and
14	regulations.
15	BE IT FURTHER RESOLVED that the term of this grant will be from
16	July 1, 1990 through June 30, 1991.
17	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18	that the Tohono O'odham Nation will not fund or operate
19	the program in the interim while negotiations are still
20	being conducted and no executed grant has been awarded by
21	the Inter-Tribal Council of Arizona
22	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23	that the Tohono O'odham Nation's Officials, to wit: The
24	Chairman, Vice Chairman and any designated official are
25	hereby authorized to negotiate and execute the grant,
26	provided, however, that any amendments affecting the
27	funding or funding levels of this grant shall be submitted
28	for further prior approval by this Council.
